We've made it easy to reach out to your local lawmakers and keep them aware of key issues and legislation affecting credit unions. With pre-composed emails that highlight our stance on a variety of issues, we ask for their support or opposition. It's an easy way to make your voice heard.

Simply choose an issue, fill in your information, and click "Send."

- Member Activation Program (MAP) gets your members engaged in credit union advocacy.
- We provide plug-and-play content, you deliver the content to members and your members discover ways to play a role in the future of their credit union.

82% of CU members say advocacy outreach makes them want to conduct <u>more</u> <u>business</u> with their credit union.



Advocacy communications strengthen the credit union member loyalty bond 77% more favorable to CU



3% click through rate on take action asks – leading to more contacts with lawmakers



Average **26% open rate** among MAP email recipients... with **only 0.01% opt-out**





Project Zip Code (PZC)

- Project Zip Code (PZC) is a user friendly, **secure** computer program that counts your members and matches them by congressional district, state legislative district and county.
- PZC is the only way to accurately reflect member counts based on legislative districts without estimating.
- 21 / 43 MT credit unions have run PZC
- This reflects only 304,044 members out of the state's 429,377!

- In some cases, a particular state will develop their own "microsite" in defense of a state-legislative battle.


